We've enjoyed another successful year working as your partner in New York, and we're excited for what the future still holds. Together we successfully extended bus camera law for five years, which otherwise would have expired at the end of 2024. Our firm was able to lobby to pass legislation on rebuttable presumption, which added language stating bus stoppages are presumed to be for the purpose of receiving or discharging passengers.
