Re: Lobbying Services Agreement Proposal

Dear Mr. Randazzo,

This Agreement is between Bus Patrol America LLC., ("Company") and McBride Consulting & Business Development Group ("Consultant") agree to engage in lobbying activity on its behalf before the administration, executive and legislative branches of the State of New York, and the Counties of Nassau and Suffolk, as it relates to advancing Company's school bus safety products and programs.

Scope of Services:

- Consultant will perform Government Relations (lobbying) work before the Counties of Nassau and Suffolk, and Towns, Villages, and Cities in Nassau County to educate, and promote Company's mission, and address questions or concerns regarding Company's school bus safety programs.
- Consultant will work with parties in Nassau County to address any jurisdictional issues impeding the efficient operations of the County's bus camera safety program.
- Consultant, will, at the direction of Company's executive(s), draft responses or respond directly to project inquiries from elected officials and or media outlets, as well as provide crisis communications support as needed.

Term:

The term of this Agreement shall commence as of February 6, 2023 and continue until July 5, 2023. This term may be extended pursuant to the mutual written agreement of the parties. In consideration of such aforementioned lobbying services rendered or to be rendered, Company will pay to Consultant \$5,000 per month, due and payable upon the first day of each month, with the exception of the initial fee, which is due upon the execution of this Agreement.

This Agreement shall at all times be governed, construed, and interpreted in accordance with the laws of the State of New York and in the event of any disagreement between the Parties, it shall be subject to mandatory adjudication before the American Arbitration Association whose determination shall be conclusive. Such determination may be enforced in any Court in New York State. The prevailing Party shall be awarded all reasonable costs of such adjudication and litigation if necessary.

New York State Lobbying Law:

Company agrees to pay all required lobbying registration fees in the respective jurisdictions where lobbying is performed.

Company and Consultant each acknowledge some of the services to be furnished hereunder may compromise lobbying activity under state and local law, including the NYS Lobbying Act and State Finance Law. As such, Company hereby expressly authorizes Consultant to engage in lobby activity on its behalf during the effective term of this Agreement. Company and Consultant further acknowledge that Client will be required to make periodic lobby disclosure filings detailing the lobby activity undertaken. The Company will be responsible for filing forms accordingly with the State of New York where lobbying is to take place. Links to these forms are provided below for your convenience.
