Dear Mr. Monell:

As you know, pursuant to the authorization letter dated January 23, 2024, Greenberg Traurig, LLP (“GT”) is currently providing lobbying services to BusPatrol America, LLC (“BusPatrol”) before New York State legislative officials and agencies. Effective immediately, GT will begin providing lobbying services to BusPatrol in the City of New York. Therefore, we must register as a lobbyist with the New York City Clerk.

In order to complete our registration with the City of New York, we need you to sign below acknowledging that you have authorized Greenberg Traurig, LLP to perform work as a lobbyist for BusPatrol America LLC in the City of New York. This authorization for the City work is effective immediately and shall continue through June 30, 2025, subject to your right to cancel. The additional fee for these services will be \$3,300 for the month of July and \$6,500 per month thereafter and will be in addition to the current fee being paid to GT by BusPatrol for State lobbying services. Please note that these services shall be in addition to other, non-lobbying services that may be provided to such entity and all other terms and conditions of the original authorization remain in full force and effect.

As a client retaining a lobbyist, you will be required to file client disclosure reports with the NYS Commission on Ethics and Lobbying in Government and the New York City Clerk. At your request, we will assist you with your routine filings at no additional charge.
