Extended Agreement Between BusPatrol America and Upstate Strategic Advisors

Upstate Strategic Advisors agrees to provide lobbying, government affairs and consulting services to **BusPatrol America** effective August 1, 2021 through July 31, 2022 for a fee of \$7,500 per month. This fee will be paid in monthly installments on the first of each month with the first payment due upon the signing of this agreement. **BusPatrol America** will reimburse Upstate Strategic Advisors for reasonable travel expenses such as tolls, overnight accommodations and meals.

In accordance with the New York State Lobbying Act, Upstate Strategic Advisors is required to register with the New York State Joint Commission on Public Ethics (JCOPE). As a client retaining a lobbyist, **BusPatrol America** will be required to file Client Semi-Annual Reports with the JCOPE. It will be the responsibility of **BusPatrol America** to file said reports in accordance with JCOPE's requirements.

This agreement can be cancelled by either party with a 60 day written notice and provided that all billings are current.
