RE: Bally's Corporation Retainer Agreement and Registration with the New York State Commission on Ethics and Lobbying in Government ("Commission") and New York City Office of the City Clerk ("City Clerk")

Dear Mr. Eaton:

This letter is to confirm that Pitta Bishop & Del Giorno LLC ("Pitta Bishop") has been retained to represent Bally's Corporation ("Bally's") before all governmental agencies and bodies of New York State and New York City government effective as of January 1, 2024 and through December 31, 2024.

It is understood that because certain of the services performed by us on Bally's behalf, may be deemed to be lobbying services, periodic filings with the Commission and the City Clerk will be required of both Pitta Bishop and Bally. Once Bally is registered as a lobbyist client with New York State you will be required to file semi-annual reports with the Commission by July 15th of the current year and by the 15th day of January of the following year. In addition, once Bally registers as a lobbyist client with New York City, you will be required to submit a client annual report electronically to the City Clerk's office by January 15th of the following year. We will at the appropriate time send to you (a) letter(s) reminding you of these deadlines and we will, of course, assist you with these filings.

This confirms our understanding and agreement that no lobbying services will be performed by Pitta Bishop on behalf of Bally's until the proper documentation has been filed with both the Commission and the City Clerk.

The rate of compensation for our services shall be \$15,000 per month, plus reasonable disbursements. Payments of fees shall be due at the beginning of each service month. Disbursements shall be paid within thirty (30) days of the billing date. This agreement may be terminated by either party, with or without cause, upon thirty (30) days written notice to the other.

During the course of our engagement, it may become necessary or desirable, from time to time, to retain other government relations professionals and personnel, not employed by our firm, to assist us in performing the services you require. Any such retention would be subject to your prior written approval and the fees for services rendered by such other professionals would be billed to you separately as a disbursement, without mark up or adjustment.

We bill on a monthly basis and require payment within thirty (30) days of receipt of our bill. You are liable for the payment of any bill. If you dispute or have a question about any bill, please contact me immediately. If we receive no comment concerning a bill within sixty (60) days of receipt, the bill will be deemed accepted and approved by you.

This agreement may be terminated by either party in the event of a material default, upon written notice to the other party, provided that if such breach is reasonably curable, specific written notice of such breach shall be provided and the termination shall be effective if the breach is not cured within ten (10) days of receipt of such notice.

Any unresolved disputes between us arising out of or under this agreement shall be resolved by final and binding arbitration before an arbitrator selected by our mutual agreement, and failing our agreement, pursuant to the rules of the American Arbitration Association.


